**WHEREAS**, the Ocean County Board of Commissioners has determined that a need exists for Professional Land Surveying Services for Various Projects, for Survey of Pinehurst Road (C.R. 539) at Joint Base McGuire-Dix-Lakehurst (MDL) National Guard Entrance, Plumsted Township, Ocean County; and

**WHEREAS**, the Board considers it necessary and desirable to engage a Consultant Land Surveying service firm from a list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on February 21, 2024 and referred to as contract number QP2024-51; and

**WHEREAS**, Adams, Rehmann & Heggan Associates, Inc. is qualified to provide the required Professional Land Surveying Services in accordance with their proposal at a not to exceed cost of \$100,958.93; and

**NOW, THEREFORE, BE IT RESOLVED** by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:
