RESOLUTION

WHEREAS, a current contract exists for the bid titled **RIPRAP** which was awarded on March 4, 2020 and assigned contract number B2020-25; and

WHEREAS, the contract terms included an award period of one (1) year and the County reserved the right to extend the contract for one (1) additional year by mutual agreement between the County and the Contractor at no increase in base price; and

WHEREAS, the Road Department is requesting approval to extend the current contract for the additional one (1) year as mentioned above and the Contractors have agreed to such terms in writing.

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY** as follows:

1. The Director and Clerk of the Board are hereby authorized and directed to enter into an extended contract with **Trap Rock Industries LLC**, and **Stavola Construction Materials, Inc.**, accepting their requests for the continued furnishing and delivery of **RIPRAP** for the County of Ocean for the extended contract period of March 4, 2021 through March 3, 2022 under the same terms and conditions.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, County Purchasing Agent, Department of Finance, Department of Parks and Recreation, Road Department, Department of Solid Waste Management, and Trap Rock Industries LLC and Stavola Construction Materials, Inc., the successful bidders.
