WHEREAS, on March 29, 2022, pursuant to legal advertisements therefor, no bids were received for the furnishing and delivery of CATCH BASINS AND MANHOLE CASTINGS NO. II, for the County of Ocean; and

WHEREAS, no responsive bids were received for Item Nos. 5 and 7 for the second time; and

WHEREAS, N.J.S.A. 40A:11-5(3) provides that, in the event no qualified bids are received on two occasions, a governing body may enter into a negotiable contract.

NOW, THEREFORE, BE IT RESOLVED by the BOARD COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The County Purchasing Agent is hereby authorized and directed to enter into negotiations leading to the furnishing and delivery of Item Nos. 5 and 7 for the furnishing and delivery of CATCH BASINS AND MANHOLE CASTINGS NO. II, for the County of Ocean, this contract shall be in effect from date of award until March 15, 2023, or until delivery is complete unless otherwise stated. The County reserves the right to extend the term of the contract pursuant to N.J.S.A. 40A:11-15.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, County Department of Purchasing, Department of Finance and Vehicle Services.
