INTRODUCTION

The County of Ocean is a County of Fifth Class as defined in N.J.S.A. 40A:6-1 et seq. Pursuant to N.J.S.A. 19:44A-20.4 et seq., the County of Ocean requests qualifications from vendors capable of providing professional engineering services for underground storage tanks for a one year contract term.

The successful vendor(s) must have a minimum of ten (10) years experience in providing these services.

METHOD OF SUBMISSION

The County of Ocean is accepting **only** electronic proposals for this RFQ. Submitting your proposal manually is cause for rejection.

You may only submit one (1) proposal. **DO NOT** submit a hard copy of your electronic submission.

During the performance of this contract, the contractor agrees as follows:

The CONTRACTOR shall, at its own expense, appear, defend and pay any and all charges for legal services and any and all costs and other expenses arising from such action or administrative proceeding or incurred in connection therewith. In any and all complaints brought pursuant to the COUNTY'S grievance procedure, the CONTRACTOR agrees to abide by any decision of the COUNTY which is rendered pursuant to said grievance procedure. If any action or administrative proceeding results in an award of damages against the COUNTY or if the COUNTY incurs any expense to cure a violation of the ADA which has been brought pursuant to its grievance procedure, the CONTRACTOR shall satisfy and discharge the same at its own expense.

It is further agreed and understood that the COUNTY assumes no obligation to indemnify or save harmless the CONTRACTOR, its agents, servants, employees and subcontractors for any claim which may arise out of their performance of this Agreement. Furthermore, the CONTRACTOR expressly understands and agrees that the provision of this indemnification clause shall in no way limit the CONTRACTOR'S obligations assumed in this Agreement, nor shall they be construed to relieve the CONTRACTOR from any liability, nor preclude the COUNTY from taking any other actions available to it under any other provisions of this Agreement or otherwise at law.

SCOPE OF WORK

A. Underground Storage Tank Services:

1. Provide a qualified Professional Engineer who is thoroughly knowledgeable with underground and aboveground tanks, piping, sensors, monitors, and dispenser systems. This includes spill and overfill prevention, release detection, product and equipment compatibility, corrosion protection, vapor recovery, record keeping, NJDEP permits and notification requirements, underground storage tank (UST) upgrading and closure.
2. With experience in UST design, operational, and maintenance requirements, in accordance with New Jersey Administrative Code and 40 CFR 280, and 40 CFR 112.
3. Capable of providing guidance about regulatory requirements, including permitting, design, operation, closure plans and remediation and possesses communication and coordination skills required to assist with design, bid, and construction phases

The engineer will perform the following tasks:

4. Recommend courses of action to the County regarding regulatory requirements of the NJDEP, including permitting, design, operation,
5. Provide bid specifications, drawings and documents necessary to close UST sites, upgrade UST sites, install ASTs, identify/resolve issues pertaining to NJDEP regulatory requirements
6. In conjunction with the County Engineer, coordinate shop drawing reviews.
7. Consult with the County Engineer if any Contractor requests interpretations of the meaning and intent of the drawings and specifications and assist in the resolution of questions which may arise.
8. Assist the County Engineer in preparing a punchlist of incomplete or unsatisfactory items pertaining to USTs

B. Site Remediation Services:

1. Provide qualified Licensed Site Remediation Professionals (LSRP) who have in-depth understanding of Site Remediation Reform Act (SRRA) and the issues associated with petroleum contaminated sites. The LSRP must possess communication and coordination skills required to effectively carry out the responsibilities of interacting with the New Jersey Department of Environmental Protection (NJDEP).

The LSRP will perform the following tasks:

2. Perform preliminary assessments/site investigations
3. Oversee well installation and decommissioning

4. Provide remedial groundwater investigations providing potential alternative sampling methodologies for horizontal and vertical delineation.
5. Recommend compliance with administrative and technical requirements for the remediation of contaminated sites
6. Provide cost estimates of projected future remediation
7. Monitor, report and remediate contaminated sites at the Ship Bottom, Lakewood and Jackson road garages.
8. Develop Response Action Outcomes and associated outcomes leading to a No Further Action/Response Action Outcome letter
9. Provide potential oversight of emergency response and cleanup efforts, ecological evaluation and human health concerns
10. In conjunction with County staff, recommend courses of action when requirements of the NJDEP are not being fulfilled

ALL SUBMISSIONS MUST INCLUDE THE FOLLOWING MINIMUM INFORMATION:

1. All required documents provided in the Vendor Questionnaire must be filled out and included with your submission. *Please note that, where applicable, the County's preferred method of document submission is DocuSign.*
2. Name of the individual(s) to be assigned to perform the tasks. Experience of the individual(s) to be assigned including a listing of experience with the County of Ocean and/or experience with New Jersey.
 - a. The Professional Engineer must have minimum of 10 years UST experience.
 - b. The Licensed Site Remediation Professional (LSRP) must have a minimum of 10 years remediation experience.
3. A statement concerning the ability of the vendor to perform tasks assigned by the County in a timely fashion.
4. A description of the support staff available to the individual(s) to be assigned.

SUBMISSION REQUIREMENTS

All responses to the Request for Qualifications ("RFQ"):

1. Must be submitted electronically and must be received prior to 4:00pm, prevailing time on the date on which they are to be unsealed.
2. The County will not be responsible for late submissions and no responses to this RFQ will be accepted by the County if received after the time stipulated above.

EVALUATION CRITERIA

The Ocean County Engineer shall designate a committee to review and rank all responses. The selection criteria to be used in awarding a contract for the services described herein, shall include:

1. Qualifications of the individuals who will perform the tasks and the amounts of their respective participation; experience with New Jersey.
 - a. The Professional Engineer must have a minimum of 10 years UST experience.
 - b. The LSRP must have a minimum of 10 years remediation experience.
2. Experience in providing the services requested by the County and references related thereto; experience with New Jersey.
 - a. Provide a summary of various UST projects performed over the last 5 years. Include summaries such as design of piping, sensors, monitors, dispenser systems, corrosion protection, vapor recovery, UST upgrading, UST closure plans, and analysis of product and equipment compatibility.
 - b. Provide a summary of environmental projects performed over the last 5 years. Include descriptions of preliminary site investigations and assessments, remedial groundwater investigations, technical compliance administration for the remediation of contaminated sites, estimates of projected future remediation costs, and resolution of issues associated with petroleum contaminated sites.
3. Ability to perform the tasks in a timely fashion, including staffing and familiarity with the subject matter and the County;
4. Location (distance) of primary office in relation to the County administrative offices;
5. Recent, current and projected work load of the vendor;
6. Thoroughness and completeness of the applicant's submittal.

Ranking

All complete and qualified proposals will be ranked in accordance with the evaluation criteria.

QUALIFYING VENDORS

The County of Ocean intends to qualify a vendor or vendors that best meet the needs and interests of Ocean County. The County reserves the right to negotiate the terms and conditions of a contract with the successful vendor or vendors to obtain the most cost advantageous services for the County, on a Project Specific basis. A Purchase Order will be generated for each specific project and will be the contract for that project.

The County reserves the right to reject any or all proposals in accordance with N.J.S.A. 40A:11-13.2, or to waive any informalities and non-material defects in the proposals and to accept any proposal deemed in the best interest of the County.

It is to be understood by the proposer that their proposal is submitted on the basis of specifications prepared by the County and the fact that any proposer is not familiar with these specifications or conditions will not be accepted as an excuse.

INDEMNITY CLAUSE

The proposer, if awarded a contract, agrees to protect, defend and save harmless the County against any damage for payment for the use of any patented material process, article or device that may enter into the manufacture, construction or form a part of the work covered by either order or contract, and he further agrees to indemnify and save harmless the County from suits or actions of every nature and description brought against it, for, or on account of injuries or damages received or sustained by any party or parties by, or from any of the negligent acts of the contractor, his servants or agents.

INSURANCE REQUIREMENTS

The contractor shall maintain primary insurance to protect against all claims under Worker's Compensation, Comprehensive General Liability and Automobile. Except for Worker's Compensation, all coverage shall apply as primary coverage with respect to any other insurance or self-insurance program afforded to the County. There shall be no endorsement or modification of this coverage to make it excess over other available insurance/coverage; alternatively, if the CGL and umbrella, excess of reinsurance states that it is pro rata, it shall be endorsed to be primary with respect to the County. Primary coverage shall be subject to approval for adequacy of protection as per the following limits:

Worker's Compensation

1. Limits according to Worker's compensation Laws of the State of New Jersey.
2. Contractor's Liability not less than \$100,000.

Comprehensive General Liability

1. Bodily Injury - \$500,000 per person; \$1,000,000 per occurrence.
2. Property Damage - \$1,000,000 per occurrence.

Comprehensive General Liability shall include the following:

1. Coverage for explosion, collapse or underground hazards.
2. Occurrence basis coverage.
3. Broad form property damage coverage.
4. Coverage for personal injury sustained by any person as a result of an offense directly or indirectly related to the employment of such person by the insured.

Comprehensive Automobile Liability, if applicable, shall include the following:

Business auto liability insurance or its equivalent with a minimum limit of \$1,000,000 per accident and including coverage for all of the following:

- a. Liability arising out of the ownership, maintenance or use of any auto;
- b. Auto non-ownership and hired car coverage.
- c. Contractor's Worker's Compensation, Comprehensive General Liability and Comprehensive Automobile Liability arising out of subcontractor's operations shall be identical as that listed above.

Professional Liability

Errors and Omissions Coverage - not less than \$1,000,000.

Copies of each insurance certificate shall be furnished to the County with Proposal (when requested) and must state the County of Ocean is additionally insured.

ADDITIONAL INFORMATION

Payments will be made upon the approval of vouchers submitted by the successful proposer in accordance with the requirements of the Board of Commissioners and subject to the Board of Commissioners customary procedures. The County will not pay interest or late fees regardless of language provided.

The County of Ocean is exempt from any State sales tax or Federal excise tax.

Ocean County Board of Commissioners will make award within sixty (60) days after receipt of proposals.

“All contractors must comply with the provisions of New Jersey Statute Title 40A:11-18, when applicable.”

PAY TO PLAY REQUIREMENTS

Starting in January 2007, all business entities are advised of their responsibility to file an annual disclosure statement of political contributions with the New Jersey Election Law Enforcement Commission (ELEC) pursuant to N.J.S.A. 19:44A-20.27 if they receive contracts in excess of \$50,000 from public entities in a calendar year. CERTIFICATION OF NON-INVOLVEMENT IN PROHIBITED ACTIVITIES IN IRAN

Pursuant to N.J.S.A. 52:32-58, the proposer must certify that neither the proposer, nor one of its parents, subsidiaries, and/or affiliates (as defined in N.J.S.A. 52:32-56(e)(3)), is listed on the Department of the Treasury's List of Persons or Entities Engaging in Prohibited Investment Activities in Iran and that neither is involved in any of the investment activities set forth in N.J.S.A. 52:32-56(f). If the proposer is unable

to so certify, the proposer shall provide a detailed and precise description of such activities. Prior to contract award or authorization, the contractor shall provide the Contracting Agency with a completed Certification on Non-Involvement in Prohibited Activities in Iran.

TRANSITIONAL PERIOD (excluding Professional Contracts)

In the event services are terminated by contract expiration or by voluntary termination by either the Contractor or the County of Ocean, the Contractor shall continue all terms and conditions of said contract for a period not to exceed one month, at the County’s request.

NEW JERSEY BUSINESS REGISTRATION CERTIFICATE

Pursuant to N.J.S.A. 52:32-44, Ocean County (“Contracting Agency”) is prohibited from entering into a contract with an entity unless the bidder/proposer/contractor, and each subcontractor that is required by law to be named in a bid/proposal/contract has a valid Business Registration Certificate on file with the Division of Revenue and Enterprise Services within the Department of the Treasury.

Furthermore, the CONTRACTOR expressly understands and agrees that the provision of this indemnification clause shall in no way limit the CONTRACTOR'S obligations assumed in this Agreement, nor shall they be construed to relieve the CONTRACTOR from any liability, nor preclude the COUNTY from taking any other actions available to it under any other provisions of this Agreement or otherwise at law.
