

**RE: Pricing Assumptions** 

The purpose of this letter is to clarify pricing for Tectyl 2423 HAPS Free Black application.

The pricing listed in part four (4) Pricing, SECTION III – APPLCIATION OF TECTYL 2423 HAPS FREE BLACK OR APPROVED EQUAL of this bid assumes the following:

- Vehicles are no older than 5 years
  - o Older vehicles will require an assessment to determine if additional rust remediation is required. Rust remediation will be charged at a rate of \$65/hr
- Vehicles do not already have an existing wax based undercarriage coating
  - Wax based undercarriage coatings will need to be removed prior to Tectyl 2423 HAPS Free Black application. Wax based undercarriage coating removal will be charged at a rate of \$65/hr
