RESOLUTION

November 1, 2023

**WHEREAS**, the County of Ocean wants to protect the historic nature of the Rockefeller forest at Ocean County Park; and

**WHEREAS**, there exists a need for preparation of forest stewardship plan to guide the management of the natural resources in these forest lands; and

**WHEREAS**, the Consultant Selection Review Committee recommended One (1) firm to be qualified to provide Forestry Consulting Services to be performed on an as need basis, where and as directed by Ocean County; and

**WHEREAS**, the Ocean County Board of Commissioners acknowledged that the one (1) firm is qualified and eligible to provide Forestry Consulting Services referred to as contract number QP2023-69; and

**WHEREAS**, the County of Ocean has received a proposal from Pine Creek Forestry LLC, Inc., 1405 Chews Landing Road, Suite 31, Laurel Springs, New Jersey 08021; and

**WHEREAS**, the bidder submitted a proposal for Forestry Consulting Services in the lump sum fee of \$5,570.00; and

**WHEREAS**, this contract is awarded in compliance with the provisions of N.J.S.A 19:44A-20.4 et seq., the New Jersey "Pay-to-Play" Law.

**NOW, THEREFORE, BE IT RESOLVED** by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. It authorizes the expenditure for Forestry Consulting Services to Pine Creek Forestry LLC in an amount not to exceed \$5,570.00 from the Ocean County Parks Ordinance Fund, Account Number 301-250-x224.
2. Certified copies of this Resolution shall be made available to County Administrator, County Parks Director, County Finance Director, County Auditor, County Counsel, and Pine Creek Forestry, LLC.
