WHEREAS, on October 6, 2020, pursuant to legal advertisements therefor, sealed bids were received for the furnishing and delivery of CULVERT AND CART PATH REPAIR AT ATLANTIS GOLF COURSE, County of Ocean, State of New Jersey, in accordance with plans and specifications prepared by T&M Associates, Consulting Engineers and approved by the Ocean County Board of Chosen Freeholders; and

WHEREAS, after the receipt and examination of same, the County Purchasing Agent referred all bids to Suburban Consulting Engineers, Inc. for study and recommendation to the Board; and

WHEREAS, the Consulting Engineers have now recommended to this Board that the lowest qualified bid namely that of OCEAN CONSTRUCTION, LLC be accepted for the CULVERT AND CART PATH REPAIR AT ATLANTIS GOLF COURSE, County of Ocean, State of New Jersey.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF CHOSEN FREEHOLDERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with Ocean Construction, LLC, accepting their bid for items 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and 12. For a Lump Sum Award (Item #'s 1 - 12) of \$127,295.45. For the CULVERT AND CART PATH REPAIR AT ATLANTIS GOLF COURSE for the County of Ocean, State of New Jersey, in accordance with plans and specifications prepared by Suburban Consulting Engineers, Inc. Project to be completed within 90 calendar days of Notice to Proceed. Project to have a Liquidating Damage Clause of \$250.00 per day after date of Contract completion. Project to start on or about November, 2020.

2. The Department of Finance has certified that funds are available in Account No. 301-010-C719 in the amount of \$1,085.00 and Account No. 301-250-C821 in the amount of \$126,210.45 to cover this contract and the amount of the contract shall be encumbered against the said Appropriations.

3. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2020-152CE.

4. Be if further resolved that certified copies of this Resolution shall be made available to each of the following:

a. County Auditor;

b. County Department of Purchasing;

c. Department of Finance;

d. County Parks Department; and

e. Suburban Consulting Engineers, Inc., who shall promptly notify the successful bidder that they are the successful bidder and the amount of and items covered by their bid; said Consulting Engineers shall also attend to having said successful bidder enter into a good and binding contract for the faithful compliance of their bid, and have the original copies of the contract filed with the Clerk of this Board.
