WHEREAS, on October 20, 2021 a resolution was adopted awarding a purchase order to French & Parrello Associates, P.A. for Consultant Material Sampling, Inspection and Testing Services for Reconstruction and Resurfacing of County Route 539 from Route 72 to Route 530, Barnegat, Lacey, and Manchester Townships, No. II, under contract QP2021-75 for the lump sum fee of SEVENTEEN THOUSAND SEVEN HUNDRED FIFTY AND 00/100 DOLLARS (\$17,750.00); and

WHEREAS, it has been determined that additional Consultant Material Sampling, Inspection and Testing Services be conducted in the project area; and

WHEREAS, funds are available in Account Number 301-185-X002-6600 in the amount of FIVE THOUSAND ONE HUNDRED FORTY NINE AND 71/100 DOLLARS (\$5,149.71) to cover this additional work; and

NOW, THEREFORE, \mathbf{BE} IT **RESOLVED** the **BOARD** COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, that the project specific proposal is amended to include these additional Consultant Material Sampling, Inspection and Testing Services for Reconstruction and Resurfacing of County Route 539 from Route 72 to Route 530, Barnegat, Lacey, and Manchester Townships, No. II, in the County of Ocean.
