WHEREAS, after the receipt and examination of same, the County Purchasing Agent referred all bids to T&M Associates, Consulting Engineers for study and recommendation to the Board; and

WHEREAS, the Consulting Engineers have now recommended to this Board that the lowest qualified bid namely that of CHAPPELLE MECHANICAL, INC. be accepted for the SOUTHERN ANIMAL SHELTER HVAC UPGRADES, County of Ocean, State of New Jersey.

NOW. THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with Chappelle Mechanical, Inc., For a Total Base Bid Award of \$1,185,000.00, which includes Allowance #1 in the amount of \$100,000.00 and Allowance #2 in the amount of \$130,000.00 for the SOUTHERN ANIMAL SHELTER HVAC UPGRADES for the County of Ocean, State of New Jersey, in accordance with plans and specifications prepared by T&M Associates, Consulting Engineers. Project to be completed within 260 calendar days of Notice to Proceed. Project to have a Liquidating Damage Clause of \$1,000.00 per day after date of Contract completion. Project to start on or about February 2024.

The Department of Finance has certified that funds are available in Account No. 301-010-X123 in the amount of \$329,656.65; Account No. 301-010-X225 in the amount of \$320,000.00; Account No. 301-010-X318 in the amount of \$500,000.00 and Account No. 016-010-6040 in the amount of \$35,343.35 to cover this contract and the amount of the contract shall be encumbered against the said Appropriations.
- 3. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2024-15CE.
- 4. Be if further resolved that certified copies of this Resolution shall be made available to each of the following:
  - a. County Auditor;
  - b. County Department of Purchasing;
  - c. Department of Finance;
  - d. Buildings & Grounds Department; and
- e. T&M Associates, Consulting Engineers, who shall promptly notify the successful bidder that they are the successful bidder and the amount of and items covered by their bid; said Consulting Engineers shall also attend to having said successful bidder enter into a good and binding contract for the faithful compliance of their bid, and have the original copies of the contract filed with the Clerk of this Board.
