## RESOLUTION

WHEREAS, a current contract exists for the bid titled INMATE COMMISSARY AND BANKING SERVICES which was awarded on April 21, 2021 and assigned contract number B2021-37; and

WHEREAS, the contract terms included an award period of three (3) years and the County reserved the right to extend the term of the contract for two (2) additional years by mutual agreement between the County and the contractor with no increase in base price; and

WHEREAS, the Corrections Department is requesting approval to extend the current contract for the additional two (2) years as mentioned above and Keefe Commissary Network, LLC has agreed to such terms in writing.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, that the Director and Clerk of the Board are hereby authorized and directed to enter into an extended contract with Keefe Commissary Network, LLC accepting their request for the continued furnishing and delivery of INMATE COMMISSARY AND BANKING SERVICES for the extended contract period of April 21, 2024 through April 20, 2026 under the same terms and conditions.
