WHEREAS, there exists a need for Consulting Services to provide a study for Regional Emergency Medical Services in Ocean County; and

WHEREAS, the Ocean County Fire and First Aid Training Center has publicly solicited a Request for Qualifications for such work in accordance with the requirements of N.J.S.A. 19:44A-20.4 et seg.; and

WHEREAS, seven (7) firms responded with written qualifications and required documentation; and

WHEREAS, the Consultant Selection Review Committee has reviewed the proposals submitted and has recommended three (3) firms to be qualified to provide Consulting Services for Regional Emergency Medical Services; and

WHEREAS, the responses received by the County of Ocean were reviewed by the Ocean County Department of Management and Budget, Fire and First Aid Training Center personnel, and the Ocean County Consultant Selection Review Committee in accordance with the criteria approved by the Ocean County Board of Commissioners and set forth in the Request for Qualifications; and

WHEREAS, the Ocean County Department of Management and Budget, Fire and First Aid Training Center and the Ocean County Consultant Selection Review Committee has recommended that the three (3) firms listed are qualified and eligible to provide a detailed cost proposal and time required to complete a study on Regional Emergency Medical Services in Ocean County as outlined in the (RFQ) Request for Qualification:
