WHEREAS, after the receipt and examination of same, the County Purchasing Agent has referred all bids to the County Engineer for study and recommendation to the Board; and

WHEREAS, the County Engineer has now recommended to this Board that the lowest qualified bid, according to specifications, namely that of, S&G PAVING, INC., be accepted for the Construction of Barnegat Branch Trail Maintenance Contract 2024, Ocean and Lacey Townships.
