WHEREAS, a current contract exists for the bid titled **MOTOR VEHICLES: SUVS AND VANS** which was awarded on December 3, 2025 and assigned contract number B2025-179; and

WHEREAS, the contract terms included an award period of one (1) year, with a provision for a roll-over to the next model year after the manufacturer's cut-off date; and

WHEREAS, the Vehicle Services Department has requested approval to proceed with a roll-over of the 2026 model year vehicles to the 2027 model year, and All American Ford DBA Paramus Ford has agreed to such terms in writing; and

WHEREAS, funds for the materials or services described herein shall be made available through operating and expense (O&E) accounts, trust accounts, grant accounts, or capital accounts maintained by, but not limited to, the following departments: Buildings and Grounds Department, Engineering Department, Parks Department, Road Department, Solid Waste Management Department, and Vehicle Services Department;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, that the Director and Clerk of the Board is hereby authorized to approve the roll-over of the 2026 model year vehicles to the 2027 model year, with All American Ford DBA Paramus Ford, and to accept the submitted pricing as set forth in the attached price list, for the continued furnishing and delivery of **MOTOR VEHICLES: SUVS AND VANS** for the remainder of the contract period ending December 2, 2026, or until delivery is complete, under the same terms and conditions;
