RESOLUTION

July 6, 2023

WHEREAS, the COUNTY of OCEAN, has funds available for **Food Insecurity** services to provide a range of supports and assistance for residents in Ocean County lacking reliable access to a sufficient quantity of affordable healthy food; and

WHEREAS, on March 15, 2023, the Ocean County Board of Commissioners adopted a resolution authorizing the use of competitive contracting for the procurement of Food Insecurity services; and

WHEREAS, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A:11-4.3 for the services listed above; and

WHEREAS, the Ocean County Department of Human Services, Human Services Advisory Council has received and reviewed proposals for Food Insecurity services and recommends that an Agreement be awarded to **Tomchei Shabbos D'Lakewood Inc.**, 212 2nd Street, Suite 403 Lakewood, NJ 08701 to provide such services, for June 1, 2023 through September 30, 2024, with a possible extension for up to (1) additional three (3) month period, as more specifically set forth in the Agreement; and

WHEREAS, funds up to the total amount of \$2,130,000.00 shall be made available upon the adoption of the Ocean County American Rescue Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE OCEAN COUNTY BOARD OF COMMISSIONERS, OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1) The Director and Clerk of the Board are hereby authorized to enter into an Agreement with Tomchei Shabbos D'Lakewood Inc. for the period of June 1, 2023 through September 30, 2024, contingent upon the availability of funds.
- 2) The Director and Clerk of the Board are hereby authorized and directed to execute any necessary subsequent and related documents.
- 3) The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said agreement, that number being CC 2023-85.
- 4) A certified copy of this Resolution, together with a copy of the Agreement executed by the parties, shall remain on file and be available for public inspection at the office of the Clerk of the Board of Commissioners.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the Ocean County Department of Finance, County Auditor, Department of Human Services and Tomchei Shabbos D'Lakewood Inc.
