**RESOLUTION**

November 17, 2021

**WHEREAS**, the State of New Jersey, Department of Human Services, Division of Family Development, has funds available through the Social Services for the Homeless Grant for the **WORK FIRST NEW JERSEY TRANSPORTATION PROGRAM**; and

**WHEREAS**, the County of Ocean, Department of Human Services has applied to renew the Social Services for the Homeless Grant for the year 2022; and

**WHEREAS**, on November 07, 2001, the Ocean County Board of Chosen Freeholders adopted a Resolution authorizing the utilization of Competitive Contracting Procedures for the **WORK FIRST NEW JERSEY TRANSPORTATION PROGRAM**; and

**WHEREAS**, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A: 11-43 for the services listed above; and

**WHEREAS**, the Ocean County Department of Human Services has received and reviewed proposals for the Work First New Jersey Transportation Program and recommends that an Agreement be awarded to Long Beach Island Community Center, Inc. – St. Francis, 4700 Long Beach Boulevard, Brant Beach, NJ to provide such services, for January 1, 2022 through December 31, 2022, with an option to extend up to four (4) additional one-year extensions, as more specifically set forth in the Agreement; and

**WHEREAS**, funds shall be appropriated for these services in the 2022 Temporary County Budget as follows:

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS, COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

- 1.) The Director and Clerk of the Board are hereby authorized to enter into an Agreement with Long Beach Island Community Center, Inc. – St. Francis for the period of January 1, 2022 through December 31, 2022, contingent upon the availability of funds.
- 2.) The Director and Clerk of the Board are hereby authorized and directed to execute any necessary subsequent and related documents.
- 3.) The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said agreement.
- 4.) A certified copy of this Resolution, together with a copy of the Agreement executed by the parties, shall remain on file and be available for public inspection at the office of the Clerk of the Board of Commissioners.

**BE IT FURTHER RESOLVED** that certified copies of this Resolution shall be made available to the Ocean County Department of Finance, County Auditor, Department of Human Services, Long Beach Island Community Center, Inc. – St. Francis, and the New Jersey State Department of Human Services, Division of Family Development.
