RESOLUTION

November 20, 2024

WHEREAS, on February 7, 2024 a resolution was adopted awarding a purchase order to Dynamic Traffic, LLC for Traffic Engineering Professional Services for Traffic Signal Design at the Intersection of CR 17 (Whitesville Road) and CR 59 (Faraday Avenue), Jackson and Toms River Townships, Ocean County under contract QP2023-50 for the lump sum fee of TWO HUNDRED FORTY EIGHT THOUSAND ONE HUNDRED TWENTY NINE AND 84/100 DOLLARS (\$248,129.84); and

WHEREAS, it has been determined that additional Traffic Engineering Professional Services be conducted in the project area; and

WHEREAS, funds are available in Account Number 301-185-X308-6600 in the amount of EIGHTEEN THOUSAND SEVENTY FIVE AND 34/100 DOLLARS (\$18,075.34) to cover this additional work.

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, that the project specific proposal is amended to include these additional Traffic Engineering Professional Services for Traffic Signal Design at the Intersection of CR 17 (Whitesville Road) and CR 59 (Faraday Avenue), Jackson and Toms River Townships, in the County of Ocean.
