## RESOLUTION

July 2, 2025

WHEREAS, on October 18, 2023 a resolution was adopted awarding a purchase order to Stantec Consulting Services, Inc. for Traffic Engineering Professional Services for Phase 2A and 2B, 5 lane section, Reconstruction of Cross Street (CR 526), Augusta Boulevard to East Veterans Highway (CR 528), Jackson and Lakewood Townships, Ocean County under contract QP2023-50 for the lump sum fee of SEVEN HUNDRED NINE THOUSAND THREE HUNDRED TWENTY-SIX AND 62/100 DOLLARS (\$709,326.62); and

WHEREAS, it has been determined that additional Traffic Engineering Professional Services be conducted in the project area; and

WHEREAS, funds are available in Account Number 424-185-X301-6600 in the amount of FIFTY-ONE THOUSAND TWO HUNDRED NINETY-EIGHT AND 18/100 DOLLARS (\$51,298.18) to cover this additional work.

NOW, THEREFORE, BE IT RESOLVED by the BOARD COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, that the project specific proposal is amended to include these additional Traffic Engineering Professional Services for Phase 2A and 2B, 5 lane section, Reconstruction of Cross Street (CR 526), Augusta Boulevard to East Veterans Highway (CR 528), Jackson and Lakewood Townships, in the County of Ocean.
