WHEREAS, the Ocean County Board of Commissioners has determined that a need exists for Traffic Engineering Professional Services, If and Where Directed by the County Engineer at Various Locations in Ocean County; and

WHEREAS, the Board considers it necessary and desirable to engage a Traffic Engineering Professional Services firm from a list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on February 15, 2023 and referred to as contract number QP2023-50; and

WHEREAS, Urban Engineers, Inc. is qualified to provide the required Traffic Engineering Professional Services at a not to exceed cost of \$15,000.00; and

THEREFORE, BE IT RESOLVED by the **BOARD** COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:
