WHEREAS, a current contract exists for the bid titled SECURITY SYSTEMS INSTALLATION, MAINTENANCE, SERVICE AND REPAIR which was awarded on January 15, 2020 and assigned contract number B2019-201; and

WHEREAS, the contract terms included an award period of one (1) year and the County reserved the right to extend the contract for one (1) additional year by mutual agreement between the County and the Contractor at no increase in base price; and

WHEREAS, the County of Ocean is requesting approval to extend the current contract for the additional one (1) year period as mentioned above and the Contractor have agreed to such terms in writing.

THEREFORE, BE IT RESOLVED by the BOARD OF NOW, COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY as follows:

The Director and Clerk of the Board are hereby authorized and directed to enter into an extended contract with Absolute Protective Systems, Inc. accepting their request for the continued furnishing and delivery of SECURITY SYSTEMS INSTALLATION, MAINTENANCE, SERVICE AND REPAIR for the County of Ocean for the extended contract period of January 15, 2021 to January 14, 2022 under the same terms and conditions.
