WHEREAS, an Agreement was awarded to National Vision Administrators, LLC to

provide such services on the basis of the quality of their proposal for the 2023

calendar year, with an option to extend the Agreement for one (1) additional year;

and

WHEREAS, Ocean County's Department of Employee Relations wishes to utilize

the option to extend the Agreement for one (1) additional year as stated in Contract

number PP2022-148 dated December 7, 2022 with said vendor, National Vision

Administrators, LLC, setting forth terms and conditions as specified in the Proposal;

WHEREAS, partial funds for these services will be made available upon the

adoption of the 2024 Temporary County Budget with the balance to be available

contingent upon adoption of the 2024 County Budget and funding shall be made from

WHEREAS, this agreement is awarded in compliance with the provisions of
