WHEREAS, on November 5, 2025, a Contract was awarded for the furnishing and delivery of TRAILER MOUNTED AERIAL LIFT to Complete Equipment Rentals and assigned Contract B2025-149; and

WHEREAS, the County Purchasing Agent has recommended that the Contract be rescinded from Complete Equipment Rentals, as the vendor has provided notice to the County indicating that they are unable to honor their Contract at this time; and

WHEREAS, as the County does not have a continued need for these services, the County Purchasing Agent has recommended that a bid for the furnishing and delivery of TRAILER MOUNTED AERIAL LIFT not be resolicited.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY that Contract No. B2025-149, Item Nos. 1, 1A and 1B for the furnishing and delivery of TRAILER MOUNTED AERIAL LIFT awarded to Complete Equipment Rentals, is hereby rescinded. It will not be rebid.
