RESOLUTION

WHEREAS, on November 9, 2023, pursuant to legal advertisements therefor, sealed bids were received for the of FURNISHING AND INSTALLATION OF A 25 HORSE POWER ROTARY SCREW COMPRESSED AIR SYSTEM NO. II for the County of Ocean; and

WHEREAS, at the advertised time, one response was received from the following bidder:

WHEREAS, after the receipt and examination of same, the County Purchasing Agent has now recommended to this Board that the sole bid received be rejected as unresponsive.

WHEREAS, N.J.S.A. 40A:11-5(3) provides that, in the event no qualified bids are received on two occasions, a governing body may enter into a negotiable contract.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

- 1. Upon recommendation of the County Purchasing Agent, the sole bid received for the Furnishing and Installation of a 25 Horse Power Rotary Screw Compressed Air System No. II is hereby rejected.
- 2. The County Purchasing Agent is hereby authorized and directed to enter into negotiations leading to the Furnishing and Installation of a 25 Horse Power Rotary Screw Compressed Air System No. II, in accordance with N.J.S.A. 40A:11-5(3) for the contract period from date of award through December 5, 2024, a period of one (1) year, or until delivery is complete unless otherwise stated. The County reserves the right to extend the term of the contract pursuant to N.J.S.A. 40A:11-15.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, County Department of Purchasing, Department of Finance, Vehicle Services and Air Center Inc., the sole bidder.
