RESOLUTION

WHEREAS, the Ocean County Board of Commissioners has determined that a need exists for Road Design Services to provide Construction Support Services for the Reconstruction and Resurfacing of Long Beach Boulevard (Bay Avenue), Borough of Beach Haven, in Ocean County; and

WHEREAS, the Board considers it necessary and desirable to engage a Road Design Services, Various Locations throughout Ocean County, on a project specific basis, where and as directed by the County Engineer firm from a list of previously qualified firms identified in a Resolution adopted by the Board of Commissioners on December 17, 2025 and referred to as contract number QP2025-124; and

WHEREAS, Urban Engineers, Inc. is qualified to provide the required Road Design Services in accordance with their proposal at a not to exceed cost of \$20,000.00

NOW, THEREFORE, BE IT RESOLVED by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, as follows:

1. The Director and Clerk of the Board are hereby authorized to execute an Agreement with Urban Engineers, Inc. for the project entitled Road Design Services to provide services for Construction Support Services for the Reconstruction and Resurfacing of Long Beach Boulevard (Bay Avenue), Borough of Beach Haven, Ocean County.
2. Contingent upon execution of the Agreement, the County Purchasing Agent is hereby authorized to issue a Purchase Order to Urban Engineers, Inc. in an amount not to exceed \$20,000.00 with funding available in Capital Budget Account Number 301-185-X402-6600.
3. Certified copies of this Resolution shall be forwarded to the Ocean County Engineering Department, Finance Department, Purchasing Department, and Urban Engineers, Inc.
