WHEREAS, a current contract exists for the bid titled SECURITY CAMERA SYSTEMS INSTALLATION, MAINTENANCE, SERVICE AND REPAIR which was awarded on January 15, 2020 and assigned contract number B2019-205; and

WHEREAS, the contract terms included an award period of one (1) year with the County reserving the right to extend the contract for one (1) additional year by mutual agreement between the County and the Contractors at no increase in base price; and

WHEREAS, Pinnacle Integrated Systems, the primary award contractor, has advised the County, in writing, that they are unable to extend their contract for the additional one (1) year period; and

WHEREAS, Absolute Protective Systems, Inc., the secondary award contractor, has advised the County, in writing, that they are willing to extend their contract for one (1) year with no increase in base price; and

WHEREAS, the Purchasing Department is requesting to amend the contract with Absolute Protective Systems, Inc. to serve as the primary awarded vendor for the extended contract period of January 15, 2021 through January 14, 2022, with all other terms and conditions remaining in effect.

NOW. THEREFORE, BE IT **RESOLVED** by the **BOARD OF** COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY that the Director and Clerk of the Board are hereby authorized and directed to enter into an amendatory contract with Absolute Protective Systems, Inc., to serve as the primary award vendor, for the continued furnishing and delivery of SECURITY CAMERA SYSTEMS INSTALLATION, MAINTENANCE, SERVICE AND REPAIR during the extended contract period of January 15, 2021 through January 14, 2022. All other terms and conditions shall remain in effect.
