RESOLUTION

August 16, 2023

WHEREAS, there exists a need to provide One Stop Operation Management Services for the Ocean County Local Workforce Area as required by the Workforce Innovation and Opportunity Act (WIOA); and

WHEREAS, on March 15, 2017, the Board of Chosen Freeholders adopted a resolution authorizing the use of competitive contracting for the procurement of One Stop Operation Management Services; and

WHEREAS, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A:11-4.3 for the services listed above; and

WHEREAS, on July 6, 2022, the Ocean County Board of Commissioners awarded an Agreement to Educational Data Systems, Inc. (EDSI), 15300 Commerce Drive North, Dearborn, MI. 48120, to provide such services, as more specifically set forth in the Agreement; and

WHEREAS, the Agreement was for a one year period, effective July 1, 2022 through June 30, 2023, and at the successful completion of the one year Agreement, two one-year extensions could be exercised; and

WHEREAS, the Ocean County Department of Human Services desires to utilize the option to extend the Agreement for July 1, 2023 through June 30, 2024; and

WHEREAS, funds totaling \$175,000.00 will be appropriated for these services.

RESOLVED BY THE BOARD NOW THEREFORE, BE IT COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY, that the Director and Clerk of the Board are hereby authorized to enter into and execute an Agreement with Educational Data Systems, Inc. (EDSI), to provide One Stop Operation Management Services, contingent upon the availability of said funds.
