RESOLUTION

December 20, 2023

WHEREAS, N.J.S.A. 40A:11-4.3 et seq. requires the procurement of certain specialized good and services through a Competitive Contracting process; and

WHEREAS, on October 5, 2023 the Ocean County Board of Commissioners authorized the advertisement of Competitive Contracting Procedures for Kayak Kiosk Services; and

WHEREAS, Competitive Contracting Procedures have been followed in accordance with N.J.S.A. 40A:11-4.3 for the services listed above; and

WHEREAS, on October 26, 2023 one (1) response received from Rent.fun, LLC was evaluated and ranked; and

WHEREAS, the Ocean County Department of Recreation has recommended that an Agreement be awarded to **Rent.fun, LLC**, 120 West Main Street Suite 300, Northville, MI, 48167 to provide Kayak Kiosk Services, when and as directed by the Office of Parks and Recreation of Ocean County as more specifically set forth in the Agreement; and

WHEREAS, the County looks to enter into an Agreement for an initial term of three (3) years, with the option to extend for two (2) additional one (1) year periods to be mutually agreed upon by the Contractor and the County prior to each extension; and

WHEREAS, funds totaling \$14,900.00 will be appropriated for these services from Account No. 301-250-X116; and

WHEREAS, the County of Ocean will receive seventy percent (70%) revenue sharing of all kayak rentals over the course of this contract, including during the optional extensions, should they be so exercised.

NOW, THEREFORE, BE IT RESOLVED, by the **BOARD OF COMMISSIONERS** of the **COUNTY OF OCEAN, STATE OF NEW JERSEY** the Director and Clerk of the Board are hereby authorized to enter into an Agreement with Rent.fun, LLC, contingent upon the availability of funds.

- 1.) The Director and Clerk of the Board are hereby authorized and directed to enter into and execute an Agreement with Rent.fun, LLC to provide Kayak Kiosk Services for the period of three (3) years with the option to extend for two (2) additional one-year periods.
- 2.) The Director and Clerk of the Board are hereby authorized and directed to execute any necessary subsequent and related documents.

- 3.) A certified copy of the Resolution together with a copy of the fully executed Agreement shall remain on file and be available for public inspection in the Office of the Clerk of the Board.
- 4.) The contract number shall be placed on all papers, documents, invoices and vouchers pertaining to this Agreement, that number being CC2023-130.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to the County Auditor, Department of Finance, Department of Purchasing, Department of Parks & Recreation and Rent.fun, LLC.
