**RESOLUTION**

**August 2, 2023**

**WHEREAS**, a current contract exists for the bid titled MAINTENANCE, PARTS, REPAIRS, AND UPGRADES OF FUEL SYSTEMS which was awarded on August 17, 2022 and assigned contract number B2022-110; and

**WHEREAS**, the contract terms included an award period of one (1) year and the County reserved the right to extend the term of the contract for one (1) additional year by mutual agreement between the County and the contractor with no increase in base price; and

**WHEREAS**, the Vehicle Services Department is requesting approval to extend the current contract for the additional one (1) year as mentioned above and DeMaio's Incorporated has agreed to such terms in writing.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF OCEAN, STATE OF NEW JERSEY,** that:

1. The Director and Clerk of the Board are hereby authorized and directed to enter into an extended contract with DeMaio's Incorporated accepting their request for the continued furnishing and delivery of MAINTENANCE, PARTS, REPAIRS, AND UPGRADES OF FUEL SYSTEMS for the extended contract period of August 17, 2023 through August 16, 2024 under the same terms and conditions.
