**RESOLUTION**

September 30, 2025

**WHEREAS**, on January 15, 2025, the Ocean County Board of Commissioners awarded a Competitive Contract to provide **Year One, Older American Act, Title III Area Plan Contract 2025** to Caregiver Volunteers of Central Jersey for Social Support, National Family Caregiver Support Program Services and Safe Housing and Transportation Services to the elderly of Ocean County, in an amount not to exceed \$227,239.00, for the period of 1/1/2025 through 12/31/2025, and was assigned Contract No. CC2025-13; and

**WHEREAS**, due to the State’s reduction to the County’s Title III allocation and the County’s desire to offset such a reduction, it is now necessary to amend the funding allocations and/or funding sources related to National Family Caregiver Support Program Services, to reflect a total of \$60,860.00, for a total contract in the amount of \$227,239.00.

**NOW, THEREFORE, BE IT RESOLVED**, by the **BOARD OF COMMISSIONERS**, of the **COUNTY OF OCEAN, STATE OF NEW JERSEY**, that the contract dated January 15, 2025 is hereby amended the funding allocations and/or funding sources related to National Family Caregiver Support Program Services portion of the contract, with all other terms and conditions to remain in full force and effect, as follows:
