RESOLUTION

December 17, 2025

WHEREAS, on December 2, 2025, pursuant to legal advertisements therefore, sealed bids were received for the CONSTRUCTION OF INTERSECTION IMPROVEMENTS AT COUNTY ROUTE 625 (OCEAN GATE DRIVE) AND C.R. 2 (MILL CREEK ROAD)/C.R.4 (VEEDER LANE), TOWNSHIP OF BERKELEY, County of Ocean, State of New Jersey, in accordance with plans and specifications prepared by the Ocean County Engineer and approved by the Ocean County Board of Commissioners; and

WHEREAS, at the advertised time, one (1) response was received from the following bidder:

WHEREAS, after the receipt and examination of same, the County Purchasing Agent referred the sole bid to Ocean County Engineer for study and recommendation to the Board; and

WHEREAS, the County Engineer has now recommended to this Board that the sole qualified bid, namely that of EARLE ASPHALT COMPANY, be accepted for the Construction of Intersection Improvements at County Route 625 (Ocean Gate Drive) and C.R. 2 (Mill Creek Road)/C.R.4 (Veeder Lane), Township Of Berkeley.

NOW, THEREFORE, BE IT RESOLVED by the BOARD OF COMMISSIONERS of the COUNTY OF OCEAN, STATE OF NEW JERSEY, as follows:

1. The Director and Clerk of this Board are hereby authorized and directed to enter into a contract with Earle Asphalt Company, accepting their bid in the total amount of \$1,279,513.13 in accordance with plans and specifications prepared by the Ocean County Engineer. **The total Time for Completion shall be within 260 CALENDAR DAYS.** The Contractor is put on notice that if a winter shutdown period between December 15th and March 1st is required due to weather conditions, there shall be no additional payment for Demobilization/Remobilization resulting from the winter shutdown.

2. The Department of Finance has certified that funds are available in Account Number 210-185-0060 in the amount of \$36,998.00; Account Number 422-185-X203 in the amount of \$30,262.44; Account Number 300-185-X305 in the amount of \$237,252.69; and Account Number 301-185-X410 in the amount of \$975,000.00 to cover this contract and the amount of the contract shall be encumbered against the Appropriations.

3. The contract number must be placed on all papers, documents, invoices and vouchers pertaining to said contract, the number being B2025-198E.

BE IT FURTHER RESOLVED that certified copies of this Resolution shall be made available to each of the following:

- a. County Auditor;
- b. Purchasing Department;
- c. Finance Department;
- d. Director of the Planning Board; and
- e. Ocean County Engineer who shall see that the successful bidder enters into a proper contract for the faithful performance of their bid and that said contract is duly filed with the Clerk of this Board; and who shall see that the successful bidder furnishes to the County of Ocean a properly executed surety company bond for the faithful performance of their contract.
