WHEREAS, the contract terms included an award period of one (1) year and the County reserved the right to extend the term of the contract for one (1) additional year by mutual agreement between the County and the contractor with no increase in base price; and

WHEREAS, the Buildings and Grounds Department is requesting approval to extend the current contract for the additional one (1) year as mentioned above and Peterson Service Company has agreed to such terms in writing.

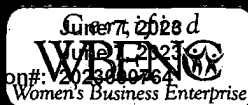
This letter is our agreement to proceed with the 1-year extension for year 2 of 2.
